INQUEST MONDAY

Mrs. Costello is being held on suspicion of murder at Lincoln Heights Jail pending a Coroner's inquest at 9:30 a.m. Monday. Police reported they found Costello's body in an upstairs bedroom when they arrived at the Costello home, 868 E. 54th St., to investigate a shooting call.

With him and attempting to dress his wounds was Harold West, 31, of 2639 E. 111th Place.

"I shot him myself," Mrs. Costello sobbed, according to police. "It was because of that man. He's always with him."
Radio Officers F. J. Collins and C. S. Hendricks later learned that Costello and West had assertedly been drinking wine during the early part of the evening. Upstairs Mrs. Costello was trying to get her two sons, Frankie, 11, and Gilbert, 8, to sleep. She asked her husband to be quiet. Then the quarrel started, the officers reported.
